## Departmental & Efficiency Bar Examination for Public Health Laboratory Technicians Seg II "A" / Grade II belonging to the Paramedical Service – 2025 (First Term)

It is hereby notified that the Efficiency Bar Examination Departmental Examination which should be passed by the officers in the post of **Public Health Laboratory Technicians** of Segment II "A" / Grade II before reaching the fourth salary step of the salary scale relevant to Grade II, will be held on 01/03/2025 and 02/03/2025 in the medium of Sinhala, Tamil and English. The venue and the time of the examination will be notified in the Admission Card.

#### 02. Qualifications

The officers who have been appointed to the post of Public Health Laboratory Technicians of Seg. II 'A" / Grade II as at 17/01/2025 and not yet completed this examination, are only eligible to apply for this examination.

N.B. Take necessary action to send applications of the officers only who has been promoted to Seg. II "A" / Grade II as at 17/01/2025 and already received the relevant letters of appointment letters.

#### 03. Applications

Applications prepared by candidates as per specimen form appended to this circular letter should be sent through the respective Heads of Institutions to reach "Director (Examinations), No. 385, "Suwasiripaya", Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10" on or before 17/01/2025 by registered post. The words "Departmental & Efficiency Bar Examination for Public Health Laboratory Technicians in Seg. II "A"/ Grade II – 2025 (First Term)"top left corner of the envelop. It is mandatory that the subject officer in personal file and that head of the Institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. Two (02) self addressed envelopes (candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs.110.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected.
