Second Efficiency Bar Examination for the posts of Control Room Operator, Automobile Technician, Overseer, Electrician and Cinema Machine Operator for which salary scale PL- 03 -2006 (A) is stipulated of Primary Technical service category of Ministry of Health – 2025 (First Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by officers in the posts of Control Room Operator, Automobile Technician, Overseer, Electrician and Cinema Machine Operator of Primary Technical service category for which salary scale PL - 03 - 2006 (A) is stipulated of Ministry of Health before expiry of 03 years after promoted to Grade II will be held on 23/03/2025 in the Sinhala, Tamil and English medium. The venue and the time of the examination will be mentioned in the admission card.

02. Qualifications

Only the officers who have got an appointment in Grade II in a posts (Control Room Operator, Automobile Technician, Overseer, Electrician and Cinema Machine Operator) for which salary scale PL- 03 -2006 (A) is stipulated of primary technical service category of Ministry of Health and those who have not yet completed the examination are eligible to apply for this examination.

N.B.:

As mentioned in the General Circular Letter No. 02-90/2015 dated 12.08.2015 of the secretary of the Ministry of Health & Indigenous Medicine Services the officers who have exceeded 3 years in the Grade II in the posts of Electrician and Cinema Machine Operator as at 27.07.2012 need not appear for this examination, since such officers are exempted from this efficiency bar examination. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.)

Take necessary action to send applications of the officers only who have been promoted to Grade II as at 05/02/2025 which is the closing date of applications and have already received the appointment letters.

03. Applications

Applications prepared by the candidates in accordance with the specimen form of application appended to this circular should be sent by registered post to reach "Director (Examinations) No.385, "Suwasiripaya", Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 05/02/2025 through their heads of Institutions. The name of the examination applied for should be mentioned as "Second Efficiency Bar Examination for the posts of PL - 03 - 2006 (A) is stipulated of Primary Technical service category - 2025 (First Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self-addressed 01 envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

N.B.:

Applications should be prepared using an A4 paper based on the Specimen from of applications so to recommended from No. 01 to 03 on the 1st page and from No. 04 to 08 on the second Page Applications that do not comply with the above format will be rejected without notice.

04. Examination fees:-

- Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.
- II The fees once paid will not be allowed to transfer for any other Examination or refunded under any circumstances.

05. Admission to the Examination:-

Total marks of 100 will be given Minimum 40 marks should be obtained to pass the examination. Duration is 1 ½ hours.
