**Efficiency Bar Examination for Officers in the Post of Public Health Inspector of Seg. II "A"/
Grade II of the Salary Scale (MT – 05) belonging to the Paramedical Service of Ministry of Health
– 2024 (1st Term)**

It is hereby notified that the Efficiency Bar Examination which should be passed by the officers in the post of Public Health Inspector of Segment II "A" / Grade II before expiring three (03) years from the date of promotion to Grade II, will be held on **10, 11/08/2024** in the medium of Sinhala, Tamil and English. The venue and the time of the examination will be notified in the admission card.

02. Qualifications

The officers who have been appointed to the post of Public Health Inspector of Seg. II "A" / Grade II as at **10/07/2024** and not yet completed this examination, are only eligible to apply for this examination.

N :B :- Take necessary actions to send applications of the officers only who has been promoted to Grade II by 10.07.2024 and already received the appointment letters. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.

03. Applications

Applications prepared by candidates as per specimen form appended to this circular letter should be sent through the respective Heads of Institutions to reach "Director (Examinations), No. 385, "Suwasiripaya", Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10" on or before **10/07/2024** by registered post. The words "Efficiency Bar Examination for Public Health Inspectors in Seg. II "A" / Grade II – 2024 (1st Term)" should be mentioned on the top left corner of the envelop. **It is mandatory to have certify fact that the candidate had satisfied the qualifications required to sit for the said Efficiency Bar**

Examination by the officer in-charge of the subject of personal file and that all the particulars furnished in each application are correct by the Head of Institution.

And, one (01) self-addressed envelopes (candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs.110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without any notice.

Note: The application should be prepared using a paper of size A4 in compliance with the specimen form of application so as to appear from 01 to 04 on the first side of the page and from 05 to 09 on the second side of the page. Applications, which do not conform to above format, will be rejected without any notice.

04. Examination fees: -

- I. Candidates who sit the examination for the first time, will be exempted from examination fees. However, in every subsequent sitting, they should affix stamps to the value of Rs. 25/= per subject in the application and cancel the same by placing their signature and the date.
- II. The fees once paid will not be transferred to other examinations or refunded under any circumstances.

05. Admission to the Examination: -

- I. Candidates whose applications have been accepted, will be issued with Admission Cards. The Admission card should be duly completed and submitted same to the Supervisor at the Examination Centre. Otherwise, they will not be allowed to sit the examination.
- II. Candidates should prove their identity to the Supervisor at the examination hall. For this purpose, one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) An Identity Card formally issued by the Ministry of Health or a relevant Institution
 - (c) Valid Driving License
 - (d) Valid Passport.

06. Scheme of the Examination: -

This examination consists of two parts viz. Departmental Examination and Efficiency Bar Examination. The Departmental Examination consists of three parts viz. Written, Oral and Practical. Each part carries 100 marks and minimum of 40 marks should be obtained in each part to pass. The Efficiency Bar Examination consist of two subjects viz. Establishments Code & Procedural Rules, and Financial Regulations. Each paper carries 100 marks. Minimum of 40 marks should be obtained in each subject to pass. The examination can be completed in one or several sittings. Applicants who sit the examination for the first time, should apply for all subjects.

07. Syllabus of the Examination

7.1.1 Subject Related Written

Duration is 03 hours. The question paper consists of 08 essay-type questions and candidates are required to answer any 05 questions out of them.


08. To follow the Regulations related to Examination Procedure
