First Efficiency Bar Examination for the post of Health Driver in Grade III for which salary scale PL-3-2006(A) is stipulated of Primary Technical Service Category of Ministry of Health – 2024 (2nd Term)

It is hereby notified that the Efficiency Bar Examination which should be passed before the expiry of 3 years after recruitment to Grade III of the post of Health Driver, will be held on 08/12/2024 in the medium of Sinhala, Tamil, and English. The Venue, and time of the examination will be mentioned on the Admission Card.

02. Qualifications

Employees who have been appointed to the post of Health Driver in Grade III and who have not yet completed the examination are only eligible to apply for this examination.

N.B. :

As mentioned in the General Circular Letter No. 02-90/2015 dated 12.08.2015 of the Secretary of the Ministry of Health the officers who have exceeded 3 years in Grade III of Health Drivers' Service as at 27.07.2012 need not appear for this examination, since such officers are exempted from this efficiency bar examination.

03. Applications

Applications prepared by the candidates in accordance with the specimen form of application appended to this circular letter should be sent by registered post to "Director (Examinations), Ministry of Health, Suwasiripaya, No.385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before

13/11/2024 through the respective Heads of Institutes. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self addressed envelope (official or private address) in the size of 9" x 4" inches, affixed stamps to the value of Rs. 110.00 should be sent along with the application. The name of the examination applied for should be mentioned as 'First Efficiency Bar Examination for the post of Health Driver in Grade III – 2024 (2nd Term)' on the top left corner of the envelope. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

[N.B.] The application should be prepared using an A4 paper based on the specimen form of application so to accomodate from No.01 to 03 on the first page and from No 04 to 08 on the second page. Applications that do not comply with the above format will be rejected without notice.

04. Examination fees:-

- I Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the stamps cage provided for in the application and cancel the same by placing their signature and the date.
- II The fees once paid will not be transferred for any other examination or refunded under any circumstances.

05. Admission to the Examination:-

- I Candidates whose applications have been accepted will be issued with Admission Cards. They should duly complete and submit the same to the Supervisor at the Examination centre. Otherwise they will not be allowed to sit the examination.
- II Candidates should prove their identity to the Supervisor at the examination hall. For this purpose one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) A formal identity card issued by the Ministry of Health or a relevant institution
 - (c) Valid Driving License
 - (d) Valid Passport

06. Scheme of the Examination:-

This examination is inclusive of one Multiple choice question paper which consists of three parts VIZ Establishments Code, Financial Regulations and Subject Knowledge. Total marks of 100 will be given. Candidates should obtain at least 40% marks to pass the examination. Duration is one hour.

07. Syllabus of the Examination

Establishments Code, Financial Regulations and Subject Knowledge Questions Paper

Part I Practical knowledge on road laws

(This part consists of 25 questions. Marks 50)

Part II Knowledge on automobile mechanics

(This part consists of 10 questions. Marks 20)


08. To follow the Regulations Related to Examination Procedure
