Efficiency Bar Examination for Grade II Nursing Officers In the Nursing Service - 2024 (2nd Term)

According to the Sri Lanka Nursing Service Minute published in extra ordinary gazette notification No 1837/8 and 19.11.2013 dated, it is notified hereby that the Efficiency Bar Examination to be passed within three years after they are promoted to the Grade II of Nursing service will be held on **09.02.2025** in Sinhala, Tamil and English medium. The venue and the time of the examination will be mentioned on the admission card.

02. Qualifications

- Officers who have been absorbed or promoted to grade II are qualified to sit for this examination.
- Nursing officers who have completed an active service period of 06 years under segment II

 (A) as at 01.11.2010 under the old nursing service minute will be exempted from the requirement of passing the 2nd Efficiency Bar Examination.
- In case of the Nursing officers who completed active service period of 05 years from the date of first appointment and the officers who satisfy with all the other qualifications required to be promoted to segment II A according to the old Nursing Service Minute during the intern period from 01.11.2010 to 31.12.2020 will be qualified to sit this examination after being promoted to grade II and they will be granted a relief period of 03 years from the date mentioned in the letter of promotion to pass the second Efficiency Bar Examination.
- For the officers who are promoted to Grade II after 01.01.2021, it is compulsory to pass the second efficiency bar Examination within 03 years from the date of promotion to Grade II.

N:B: Take necessary actions to send applications of the officers only who has been promoted to Grade II by 30.12.2024 and already received the appointment letters. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.

03. Applications

Applications for the examination should be forwarded on forms prepared by themselves as per format appended to this letter to the Director (Examinations), Suwasiripaya, Ministry of Health, 385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10 through the relevant head of institutions under registered cover to be received on or before 30.12.2024 The name of the examination applied for should be mentioned as "Efficiency Bar Examination for Grade II Nursing Officers in the Nursing Service – 2024 (2nd Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination head of division. One self-addressed envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

Note: The application should be prepared using an A4 paper based on the specimen form of application so as to accommodate from 01 to 04 on the first page and from 05 to 10 on the second page.

04. Examination fees :-

- (i) The applicants for the first time will be exempted from exam fees. The others who had applied for but not sat the Examination shall affix stamps to the value of Rs. 25/= per subject in the application and cancel them by placing their signatures and the date.
- (ii) Under no circumstance the fees once paid will be refunded or changed for another examination.

05. Admission to the Examination:-

- 05.1 Admission cards will be issued for properly perfected applications. The applicants should perfect the admission card and hand them over to the supervisor at the Examination. Otherwise they will not be allowed to sit the Examination.
- **05.2** The applicants shall establish their identity to the supervisor within the Examination center by producing one of the following.
 - (a) National Identity Card
 - (b) A formal Identity Card issued by the Ministry of Health or a relevant Institution
 - (c) Valid Driving License
 - (d) Valid Passport

06. Scheme of the Examination:-

This efficiency bar examination consists of two question papers which are **Theoretical Knowledge** in Nursing and **Ward Management**. Duration for each question paper in 03 hours and each paper will receive 100 marks. Applicants shall secure minimum of 40% marks to pass in the examination. Applicants can complete the examination at once or several occasions. At the first attempt officers should apply for all relevant subjects. (Should Request in the same language applied for the training as a student nurse before recruitment of the post.)

 - (i) Theoretical Knowledge in Nursing
 - Surgical Nursing
 - Medical Nursing
 - Pediatric Nursing
 - (ii) Ward Management
 - Patient Care Management
 - > 5'S Concept
 - > Action plan Monthly / Annually

Above each paper consists of 08 essay type questions and should answer any 05 questions.

No candidate should attempt to look at the script of another candidate and should not help any candidate either help another candidate or obtain help from another candidate or person. Further Mobile phones & the similar electronic equipment should not be used. Any candidate who disregards this rule is liable to punishment.
