It is hereby notified that the Efficiency Bar Examination which should be passed by the Legal officers of the Ministry of Health before expiring five years from the date of promotion to Grade I in the post of Legal officer belongs to Exceutive service of category and the prescribed salary scale of SL-01 - 2006 will be held on 27/04/2025 in Sinhala. English and Tamil medium. The venue and the time of the examination will be notified along with the admission card.

02. Qualifications
