It is hereby notified that the Efficiency Bar Examination which should be passed by the Legal officers of the Ministry of Health before expiration of three years from the date of appointment to Grade II in the post of Legal officer wich belongs to Exceutive category of service and the prescribed salary scale for which is SL-01 - 2006 will be held on 04/05/2025 in Sinhala, English, Tamil medium. The venue and the time of the examination will be notified along with the admission card.

02. Qualifications

Only the officers of the Ministry of Health and Indigenous Medical Services who have been appointed to grade II in a post of Legal Officers or chief Leegle officer belonging to Executive category of Service prescribed salary scale for which is SL - 01 - 2006 and the officers who have not completed the examination upto now will apply for this examination.

N.B: Take necessary actions to send applications of the officers only who has been promoted to Grade II by 09/04/2025 and already received the appointment letter. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.)

03. Applications

The name of the examination applied for should be mentioned as "Second Efficiency Bar Examination for Legal Officers of (SL – 01 – 2006) - 2025 (First Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self addressed 01 envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application.
