Second Efficiency Bar Examination for the posts belonging to the of primary unskilled service category PL - 01 - 2006(A) of the Ministry of Health – 2024 (2nd Term)

Second Efficiency Bar Examination for the posts belonging to primary unskilled service category PL - 01 - 2006 (A) of the Ministry of Health which should be passed before expiry of 03 years from the date of promotion to Grade II will be conducted on 18/08/2024 in the Sinhala, English and Tamil medium. The venue and the time, of the examination will be notified along with the admission card.

02. Qualifications:

Only the employees who have been appointed to a Grade II post belonging to the unskilled Service category PL - 01 - 2006 (A) (Karyala karya sahayaka, Packer, Book Binder, Foot- bicycle Messenger, Watcher, Store Keeper, Lift Operator, Photocopy Ronio Machine Operator, Spray Machine Operator, Assistant Media unit, Photographer - Media, Photo Assistant, Video Editor, Videographer, Saukya Karya Sahayaka (Ordinary), Saukya Karya Sahayaka (Junior) of the Ministry of Health and those who have not passed the Efficiency Bar Examination up to now can apply for this examination).

N:B :- Take necessary action to send applications of the officers only who have been promoted to Grade II by 26/06/2024 and already received the appointment letters. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.)

(N:B :- As mentioned in the General Circular Letter No. 02-90/2015 dated 12.08.2015 of the secretary to the Ministry of Health, from the above posts officers who have exceeded three years in Grade II in the post of Karyala Karya Sahayaka, Book Binder, Watcher, Spray Machine Operator, Saukya Karya Sahayaka (Ordinary), Saukya Karya Sahayaka (Junior) as at 20.07.2012 need not appear for this Efficiency Bar Examination they are exempted from the requirement of Efficiency Bar Examination.

03. Applications:

Applications prepared by the candidates as per specimen appended to this letter should be sent under Registered cover to reach the Director (Examinations) No.385, "Suwasiripaya" Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 26/06/2024 through their Heads of Institutions. The name of the examination applied for should be mentioned as "Second Efficiency Bar Examination of PL - 01 - 2006(A) - 2024 (2nd Term)" on the top left corner of the envelop. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self-addressed one (01) envelope (Candidates can write their official or private address) in the size of "9 x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

N.B. - The application should be prepared using an A4 paper based on the specimen from of applications so as to accommodate from No: 01 to 04 appear on the first page and from No 05 to 08 on the second page. Applications that do not comply with the specimen will be rejected without notice.

04. Examination Fees:

- I. Candidates who sit the examination for the first time are exempted from paying examination fees. Other candidates should affix stamps to the value of Rs. 25/= per subject in the application and cancel the same by placing his/her signature.
- II. The examination fees paid will not be transferred to any other examination or refunded under any circumstance.

05. Admission to the Examination:

- I. Admission cards are issued to the candidates whose applications are accepted. The admission card should be duly completed and submitted to the supervisor of the examiners. Otherwise he/she will not be allowed to appear for the oral test.
- II. Candidates should prove their identity to the supervisor at the Examination Hall. For this purpose, one of the following documents will be accepted.
 - a) National Identity Card
 - b) A formal Identity card issued by the Ministry of Health or a relevant Institution
 - c) Valid Driving License
 - d) Valid Passport

06. Examination Procedure

An oral examination (should answer orally to the questions asked by an examination board)

Duration : 15 Minutes

Total Marks : 100 (Minimum 40 marks should be Secured to pass)




08. To follow the Regulations Related to Examination Procedure
