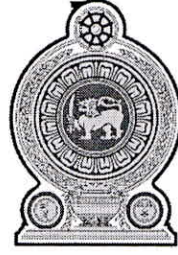

04. Vacancies due to selection for End Post list 2025 will be added with the observations.
05. It has been observed that many remarks or complaints are sent after the closing date for observations. If observations are not submitted during this due period the list published shall be considered as true and correct. Any observation remarks or complaints sent after the closing date shall not be entertained hereafter.

All heads of the institutions are advised to review, observe and feed back to Ministry of Health especially related to the below mentioned points.

- a) Check the approved cadre and currently available / in-position specialist grade medical officers in your institutions.
- b) If existing positions are over the approved cadre please justify the needs of such specialty posts or inform to Ministry of Health if those excess posts are not needed to the institutions.
- c) Any definitely vacant posts does not advertised this list or post vacant due to no pay leave or vacation of post or resigned or released to another organization should be informed to Ministry of Health before closing date.

- d) If you propose new posts to be opened within the approved carder position head of the institution should approve with the justification and the availability of other resources such as infrastructure, equipment supportive services and required human resources.
- e) Still vacant posts due to non-reporting of appointed officer from previous annual transfer list cannot be considered as vacant unless otherwise the officer is currently does not serve in the place at the time of transfer order was given.
- f) Any two or more institutions under one administration head and one financial head cannot be considered as two separate stations though located in two different geographical setups.
- g) All posts vacant due to retirement up to 31.12.2024 should be vacant even a contract basis specialist servicing at that post
