Annual Transfers of Dental Surgeons – 2024 Proposed List (for observations)

1. The proposed list of Annual Transfer of Dental Surgeons 2024 is published herewith. Please consider this as a dynamic interim list.
2. If any discrepancies are noted you are advised to inform the Directorate of Dental Services via the email address (dentalapplicationsonline@gmail.com) on or before 27/06/2024. The observed discrepancies will be reviewed by the Annual Transfer Board and if necessary will be amended in the interim list and updated in real time on the website. Discrepancies forwarded after the above stipulated deadline won't be entertained. If not informed the proposed list of Annual Transfer of Dental Surgeons 2024 will be considered as accurate.
3. Head of the Institutions are advised not to release these officers till the final transfer list is published.
4. This proposed list is based on the criteria approved by Public Service Commission in the letter numbered D/DS/C/AT/218/2024 and dated 2024.02.28
5. Application portal to forward appeals for the Appeal Stage of Annual Transfers of Grade Dental Surgeons 2024 will be opened after the stipulated deadline to forward the noted discrepancies of the Proposed list.

6. The word "NOTED NEP" marked against the names of the officers denotes that requested stations were not sufficient to allocate a post on their seniority positions. It is compulsory for them to appeal via the appeal stage of AT 2024 for vacant or potentially vacant stations forwarding a fresh list containing an adequate number of preferences. Please note that their original preferences in the initial application will not be taken into consideration by the Annual Transfer Board. In a scenario where adequate preferences are not available at their seniority positions even in the appeal stage the respective officers will be allocated a station from the remaining vacancies at the discretion of the Annual Transfer Board.

7. Officers who have made themselves denoted as Eligible or CNN/Eligible are also free to appeal for vacant or potentially vacant stations as a fresh list of preferences if they wish to get a transfer. Please note that their original preferences will not be taken into consideration by the Annual Transfer Board.
