Applications are invited from suitably qualified Specialist Dental Surgeons for end posts in the Ministry of Health. The list of end posts available is attached.

- 1. All end posts which are marked as vacant are definitely vacant.
- 2. All other end posts where Specialist Dental Surgeons have occupied are to be considered as potentially vacant as those Specialist Dental Surgeons are eligible to apply for transfer to another vacant end post in this list and their end post may fall vacant.
- 3. All Specialist Dental Surgeons in OMF who have been promoted to Specialist Grade by the Health Services Committee of the Public Services Commission by the **closing date** of the application process are eligible to apply for the posts.
- 4. Specialist Dental Surgeons are requested to indicate their preference order in the application.
- 5. It is not compulsory for Specialist Dental Surgeons to apply for this end post transfers.
- 6. Eligible applicants are hereby requested to send their application to the email address ddssonline@gmail.com. The application is available for download at the Ministry of Health website. Application should be submitted on or before 25/...../2024. Applications submitted after the closing date will NOT be accepted.
- 7. Applicants should forward their applications from their duly appointed station for the annual transfers. Applications will not be entertained if submitted through any other station other than his/her duely appointed station.

- 8. The end post placements for the year of 2025 which will be effective from 01/01/2025 will be done as per the Health Services minute appearing in the Government Gazette no. 1176/15 dated 22nd March 2001 and points will be calculated accordingly, up to the closing date of the application process.
- 9. Those who wish to withdraw the application can do so by giving it in writing to Director General of Health Services within ONE week of the closing date. No subsequent withdrawal will be entertained and if the applicant is selected to a post, he/she is compelled to take up that post. Changing of preference order will not be allowed after the closing date of application.
- Please note that undergraduate/ Post Graduate teaching and training is an important part of duties of all Specialist Grade Dental Surgeons occupying end posts.
- 11. If a Specialist Dental Surgeons has an issue with the end post vacancy list it should be informed to the Director, Dental Services Ministry of Health (within one week of the publication of end post in the Ministry of Health website).
- 12. Heads of the institutions are requested to bring the content of this circular to the notice of all Specialist Dental Surgeons in their institutions.
- 13. This notification is published with the consent of the Health Services Committee of the Public Service Commission. However, applications will be processed after receiving the formal approval of Health Service Committee of the Public Service Commission.
