02. As an eligible applicant for the Placement List 2024, it is essential that you register in the Human Resources Management Information System (HRMIS) before **09<sup>th</sup> July 2024**.

03. All Specialist Medical Officers who have completed local training are required to register in the HRMIS. Please note that only registered Specialist Medical Officers will be considered for the Placement List 2024. Any Specialist Medical Officers who fail to register by the deadline will be considered for remaining vacancies after allocating positions to registered officers in the HRMIS. Please use the following link: <https://hrmis-sm.health.gov.lk>. Use your National Identity Card Number as the username when you register in the system.

04. We urge you to complete this registration process at your earliest convenience to avoid any inconvenience.

05. Ensure to fill all relevant data fields accurately and double-check your information. Failure to comply will result in disciplinary action as per the Transfer Board's decision.
