INVITATION FOR BIDS

1. The Democratic Socialist Republic of Sri Lanka has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Health and Medical Service Improvement Project (HAMSIP). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contracts for **Procurement of Construction of New Cardiology Unit Building in District General Hospital - Trincomalee** (08-storied building with a total gross floor area of 5810 m²) and **Construction of New Cardiology and Cardiothoracic Complex Building in Teaching Hospital - Anuradhapura** (08-storied building with a total gross floor area of 7575 m²).
2. Bidding will be conducted through procedures in accordance with the applicable guidelines for Procurement under Japanese ODA Loans, and the eligible nationality of the Bidder(s) shall be **Japan and/or the Democratic Socialist Republic of Sri Lanka in the case of the Prime Contractor;** and all countries and areas in the case of the Sub-Contractors(s), as defined in the Loan Agreement.
3. **The Chairman, Standing Cabinet Appointed Procurement Committee (SCAPC)** on behalf of the Employer now invites sealed bids from eligible bidders for the above construction works and some of the eligibility criteria stipulated in the Bidding Documents are as follows:

5. The provisions in the Instructions to Bidders (ITB) and in the General Conditions of the Contract (GCC) are the provisions of the Standard Bidding Documents under Japanese ODA Loans for the Procurement of Works.
6. **A pre bid meeting will be held on 01st November 2024 at 10.00 a.m.** at the office of the Deputy Director General (Engineering Services), 02nd Floor, Ministry of Health, No. 385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10.
7. Interested eligible Bidders may obtain further information from and inspect the Bidding Documents at the office of the Deputy Director General (Engineering Services), 02nd Floor, Ministry of Health, No. 385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10.
8. Bidding will be conducted according to the two-envelopes system. Accordingly, the sealed original and duplicate bids, should be in separate envelopes and marked as "**Bids for Tender No..... (as per the above table)**" on the top-left hand corner, and submitted to the **Engineering Services Division, 02nd Floor, Ministry of Health, No. 385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10 before 12.00 p.m. on 10th December 2024.**
9. Bids shall accompany a Bid Security as stipulated in the above table. The form of the Bid Security shall be a demand guarantee issued by a commercial bank operating in Sri Lanka (approved by the Central Bank of Sri Lanka) or a bank based in another eligible country, but the security is issued through a corresponding commercial bank (approved by the Central Bank of Sri Lanka) operating in Sri Lanka as the counter guarantor.
10. Technical Bids will be opened in the presence of Bidder's representatives who choose to attend at the **Engineering Services Division, 02nd Floor, Ministry of Health, No. 385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10** soon after the bid closing.
