The Democratic Socialist Republic of Sri Lanka has received a grant from the Global Fund and intends to apply part of the proceeds of this grant to develop the Sri Lankan Hospital Accreditation Standards Book and to conduct a pilot in two selected hospitals.

The Consultancy Procurement Committee of the Department of Health, on behalf of the Directorate of Healthcare Quality and Safety, now invites eligible consultants to express their interest in providing services for the aforementioned activity.

The services to be undertaken by the consultant include;

- Conducting five (05) in-person consultative meetings to develop or to adopt the standards for accreditation in collaboration with Professional Colleges and other relevant stakeholders based on the existing tools developed. Additionally, established standards already in use locally will be utilized in the development of standards.
- 2. Prepare data collection tools, checklists, and guides based on the draft standards.
- 3. Conducting a pilot study for the developed standards in two (2) Teaching Hospitals selected in consultation with the team of the Directorate of Healthcare Quality and Safety
- 4. Conducting two (02) in-person consultative meetings for refining and finalizing the customized standards, compile and develop Sri Lankan hospital accreditation standards book and also compile finalized version of data collection tools, checklists, and guides based on the standards.

Terms of Reference

Hiring a Local Consultant to the Ministry of Health to Develop Sri Lankan Hospital Accreditation Standards Book, and to Conduct Piloting

1. Background

Despite modest economic growth, Sri Lanka has achieved remarkable health outcomes, with key health indicators comparable to those of developed nations. However, several deficiencies within the hospital healthcare system have significantly affected the overall quality of care, leading to a shortage of amenities and growing patient dissatisfaction. In response, the Ministry of Health is preparing for essential health system reforms.

One of the Ministry's top priorities is the continuous improvement of healthcare quality and patient safety. Establishing an accreditation system for healthcare institutions has been recognized as an important step in this process. Accreditation is a quality management system that evaluates healthcare institutions against established standards, ensuring they provide safe and high-quality care to the people of Sri Lanka.

As part of this effort, the Ministry is establishing the National Healthcare Accreditation Council (NHAC) to serve as the regulatory body for accrediting all healthcare institutions. The NHAC will be responsible for reviewing accreditation standards, registering and certifying surveyors from recognized training institutions, supporting healthcare facilities in achieving and maintaining accreditation, identifying barriers to improvement, and devising strategies to overcome them. The Council will also monitor accredited institutions and conduct periodic reaccreditation to ensure sustained compliance.

Given the Ministry's focus on urgent health system reforms, the accreditation process is essential. A roadmap for developing a sustainable healthcare accreditation program has been outlined by the Directorate of Healthcare Quality and Safety, under the leadership of the Secretary of Health, with input from senior Ministry officials, experts, and other stakeholders.

The first phase of this initiative will involve training a pool of surveyors in collaboration with an ISQua (International Society for Quality in Healthcare) accredited organization. These surveyors will acquire the knowledge and skills necessary to drive and sustain the accreditation process. The development and finalization of the accreditation standards will be conducted with input from professional medical colleges and the trained surveyors, under the guidance of local consultants and the DHQS. The Ministry already uses various performance indicators to evaluate healthcare institutions, including some standards developed in 2015. The new accreditation standards will build upon these existing metrics to ensure they are suited to Sri Lanka's unique context.

Following the finalization of the draft standards, they will be piloted in two selected teaching hospitals. Raising awareness among hospital staff about the accreditation process is crucial, as their involvement is essential for identifying gaps and planning improvements toward accreditation. This need for awareness has been recognized and included as a key component in the roadmap.

In the next phase, a gap analysis will be conducted by a local consultant, with support from the surveyors and trained hospital staff, to assess compliance with the newly developed standards. This analysis will identify areas for improvement and guide future action.

To support this initiative, the first phase of the project will involve hiring a local consultant to develop a comprehensive accreditation standards book in collaboration with professional medical colleges and to pilot the standards. In the second phase, a second consultant will conduct four awareness programs and assist in the gap analysis, ensuring the accreditation process is successfully implemented and sustained.

Funding for the activities related to the establishing of an accreditation system for the healthcare institutions in the country is allocated through the Health Information and Quality Improvement (HiQi) project coordinated by the Global Fund, and the project funding will be concluded by the end of June 2025.

2. Objective

The primary objective of this consultancy is to develop Sri Lankan hospital accreditation standards book and pilot the standards in selected institutions.

3. Scope of Work

The local consultant will undertake the following tasks:

- 1. Conducting five (05) in-person consultative meetings to develop the standards for accreditation in collaboration with Professional Colleges and other relevant stakeholders based on the existing standards/tools developed by suitably adopting the standards used by the internationally recognized training institutions for accreditation (eg. Indicators identified in the Quality Performance Evaluation Tool and General Indicators used by the Directorate of Healthcare Quality and Safety)
- 2. Prepare data collection tools, checklists, and guides based on the draft standards.
- 3. Conducting a pilot study for the developed standards in 2 Teaching Hospitals selected in consultation with the Director, Healthcare Quality and Safety

- 4. Conducting two (02) in-person consultative meetings for refining and finalizing the customized standards, compile and develop Sri Lankan hospital accreditation standards book and also compile finalized version of data collection tools, checklists, and guides based on the standards.
- 5. The consultant should hold regular meetings with the director and the DHQS team to discuss each step before initiation and to provide updates on the progress of activities.
- 6. The consultant should attend, the five-day survey training program conducted by a foreign consultancy firm specializing in hospital accreditation as an observer. The Consultant is required to liaise with the Consultant recruited for the gap analysis in the second phase of the project and communicate the developed Sri Lankan Hospital Accreditation Standards.

4. Deliverables with the time line

After signing the agreement, the consultant should deliver the following and the project is to be completed by 30th April 2025: Following deliverables should be submitted on or before the last working day of the stipulated period. The deliverables will be reviewed and recommended by an expert committee.

9. Payment Terms

9.1 Payment Schedule

The proposed payment schedule is as follows:

9.1.1 First Milestone Payment (37%): Upon completion of the customization of standards for accreditation in collaboration with Professional Colleges and other relevant stakeholders using standards/tools used by the internationally recognized training institutions for accreditation and suitable adoption of existing standards and indicators in the Quality Performance Evaluation Tool and General Indicators used by the Directorate of Healthcare Quality and Safety (Following conducting five (5) meetings)

Deliverable: Draft version of hospital accreditation standards.

9.1.2 Second Milestone Payment (20%): Upon submission of data collection tools, checklists, and guides developed based on the draft standards

Deliverable: Draft of the data collection tools, checklists, and guides developed based on the draft standards

9.1.3 Third Milestone Payment (14%): Upon completion of the pilot study for the customized/developed standards in 2 Teaching Hospitals

Deliverable: Short report on pilot study carried out in 2 Teaching Hospitals

9.1.4 Fourth Milestone Payment (29%): Upon submission of compiled e book/document of the final version of the customized standards for accreditation & finalized version of data collection tools, checklists, and guide based on the standards following 2 consultative meetings

Deliverables: Compiled e book/document of the final version of the customized standards for accreditation & finalized version of data collection tools, checklists, and guide based on the standards

9.2 Payment Conditions

- Approval of Deliverables: Each payment will be contingent upon the approval of the deliverables by the Secretary, Ministry of Health, recommended by Director, DHQS, DDG MSI, & DGHS to ensure that the work has met the required standards and project specifications.
- **Documentation**: The consultant must provide detailed documentation and reports for each deliverable, which will be reviewed and validated before payment is released.
- **Invoicing**: The consultant must submit an invoice for each payment installment. The invoice should include a summary of the work completed, corresponding deliverables, and the amount due.

9.2 Reimbursement of Expenses

In addition to the consultancy fee, pre-approved expenses incurred during the project, such as transportation costs for travel between DHQS and the respective hospitals, as well as accommodation expenses during the piloting phase, may be reimbursed in accordance with government circulars.
